Meeting Commenced: J. Allam called the meeting to order at 5:30 pm.

J. Kuzmeskas made a motion to approve the minutes from the March 18, 2024, Finance Committee Meeting, as submitted. K. Keppler seconded. Approved 5/0.

**Public Hearing:** DPW Director, Jesse Riedle, was present to provide an update on each of the Department Accounts listed below for the FY25 Operating Expenses, as well as Capital Requests.

**Article 2 – FY25 Trash Enterprise** is level funded from the FY24 budget, in the amount of \$1,825,082 transferred from Trash Receipts.

**J. Collamati made a motion to recommend Article 2 of the Town Warrant. Seconded by J. Kuzmeskas. Recommended 5/0.**

**Article 3 - FY25 Water Enterprise** in the amount of \$4,077,540 from Water Receipts was presented to Committee members and discussed at the March 18, 2024, Finance Committee meeting.

**K. Keppler made a motion to recommend Article 3 of the Town Warrant. Seconded by J. Collamati. Recommended 5/0.**

**Article 4 - FY25 Sewer Enterprise** in the amount of \$1,724,876 from Trash Receipts was presented to Committee members and discussed at the March 18, 2024, Finance Committee Meeting.

**J. Kuzmeskas made a motion to recommend Article 4 of the Town Warrant. Seconded by K. Keppler. Recommended 5/0.**

**Article 5 - FY25 Stormwater Enterprise** in the amount of \$887,419 from Stormwater Receipts was presented to Committee members, and discussed at the March 18, 2024, Finance Committee meeting.

**J. Collamati made a motion to recommend Article 5 of the Town Warrant. Seconded by J. Kuzmeskas. Recommended 5/0.**

The installation of security cameras and alarm system will take place for the current DPW Facility, water treatment plants, and the new Depot Street DPW Facility. This is for the purchase and installation of 12 security cameras at the locations listed.

**J. Kuzmeskas made a motion to recommend \$24,906 from Free Cash for the purchase and installation of security cameras and FOB's. K. Keppler seconded. Recommended 5/0.**

Mr. Riedle presented additional information for paving that will take place on North Main Street, as well as other roadways improvements throughout town, in the amount of \$500,000 from Free Cash.

**J. Collamati made a motion to recommend \$500,000 from Free Cash. J. Kuzmeskas seconded. Recommended 5/0.**

Request for Phase I of II, for the replacement of Well #11 that is located on Wrentham Road. This request will be funding for initial hydroengineering process, design, and bidding of the project. The project will replace 3 of the 4 wells which are on Wrentham Road.

**J. Collamati made a motion to recommend \$265,710 from Water Retained Earnings for Phase I of Well #11 replacement. J. Kuzmeskas seconded. Recommended 5/0.**

Request for \$100,000 for the sewer main replacement at the Middle School, due to a consistent number of back-ups happening with the current system.

**J. Kuzmeskas made a motion to recommend \$100,000 from Free Cash for the sewer main replacement at the Middle School. K. Keppler seconded. Recommended 5/0.**
