4. Old Business

- The balcony bracing project started about 5-6 weeks ago and will update further as it is completed. All railing caps and metal bracings underneath will be replaced.

- Spoke about Mr. Remillard's term being up and Mr. Hall resigning prematurely. This all happened and was only clarified on the Thursday before the meeting. Due to this the reorganization of the board was in order. BHA has to check with DHCD to see how long it can stay vacant. Mrs. Cartier suggested a vote on whether to hold a special election to fill the vacancy or to leave it at only 4 board members until new election. Mr. Fitzpatrick motioned to postpone until next election, Mr. Pauhlus seconds, all in favor, motion passes 4-0. It was later discussed that the next election was believed to be in May 2024

- At (705-2) 21 Arthur Street, the septic system replacement is currently in design stage with an engineer after years of failing. We will be connecting to the town sewer behind where Cumberland farms is, more to follow as we are updated

- BHA's Performance Management Review (PMR) is scheduled for July
- AUP annual audit of FY23 will be scheduled soon as well

- Occupancy Report: 667-1 will have one (1) vacancy on July 1st, 667-2 has three (3) vacancies as of June 1st. All vacancies already have verified applicants ready to move in, pending turnover of unit. All vacancies at 667-2 are going to be 2nd floor tenants transferring to the 1st floor. This causes six (6) units in total needing to be turned. No other vacancies in any other program

- Maintenance Report: BHA has had our part time maintenance staff, Bobby come in to help expedite the unit turnovers. Regular and annual inspection work orders are both being completed in a timely manner.

- Board vote needed to update the authorized signatures at Dean bank. Mrs. Sacco motions that: Mrs. Cartier, Mrs. Sacco, Mr. Paulhus, Mr. Fitzpatrick and Mr. Pelletier be the complete list and only people going forward authorized to sign, anyone else not listed should be removed. Mr. Fitzpatrick seconds, all in favor, motion passes 4-0.
