# PROJECT NARRATIVE

## Project Introduction and Overview

This Notice of Intent is being filed by the Bellingham Department of Public Works (DPW) in accordance with the Massachusetts Wetlands Protection Act (MAWPA) (M.G.L. Chapter 131, Section 40) (the Act), and its implementing regulations (310 CMR 10.00). As this is a DPW project it is exempt from the Bellingham Wetland Bylaw (the Bylaw). This Notice of Intent (NOI) is being filed for a public water supply project consisting of the construction of three replacement wells and associated prolonged pump tests, the decommissioning of three existing wells, the replacement of pumping equipment in one existing well, the installation of new underground utilities and raw water mains, the construction of four metering pits, the installation of one hydrant, the installation of a propane tank and generator on concrete pads, repaving and appurtenances. The existing raw water mains will be either capped and abandoned in place or removed at the contractor's discretion.

## Site History and Existing Conditions

The site is located south of Wrentham Road and east of 91 Wrentham Road. The majority of the well site itself is a shrub swamp, with the well site itself being located in a section of wooded upland running through the wetland. The site is located within a 100-year Flood Zone associated with Bungay Brook.

## Project Impacts and Performance Standards

All of the proposed work is a Limited Project Per 310 CMR 10.53 (3) o.

### ***Bordering Land Subject to Flooding (BLSF):***

All of the proposed work is located within the BLSF. The work will include the construction of three new replacement wells and prolonged pump tests, the installation replacement equipment in one existing well, the decommissioning three existing wells, the installation of a temporary dewatering filter, the installation of one hydrant, the construction of 240 lf of underground electric, the construction 270 lf of raw water main, the construction of a new generator and propane tank on concrete pads, repaving and appurtenances. The majority of the 9,900 sf of the work will be underground and that work will be returned to like conditions. The work on the well caps, the hydrant, monitoring pits and sampling stations, and the generator and propane tank will be at or above grade and total 400 sf of new impervious area and 800 cf of flood storage lost.

As the project is a limited project, we are requesting that flood storage compensation be waved. The proposed project has minimal flood storage lost, alternate locations and

the compensation area would require extensive vegetation clearing, and the alternate locations would be located immediately outside of the flood plain and be subject to similar sized storm events as the elevation is similar.


***Erosion control:***

An erosion control barrier will be installed between all work and the wetlands. All disturbed surfaces will be stabilized as soon as possible.

Dear Ms. Thistle:

As requested, we have delineated the wetlands on the above-referenced site. The delineation was conducted on September 3, 2024. The delineation was based on observations of the soils, the plant communities and hydrology.

The edges of Bordering Vegetated Wetlands were delineated with blue flagging labeled A1 to A97 and C1 to C3. The edge of a non-bordering vegetated wetland was delineated with blue flagging labeled B1 to B9. The wetlands and immediately adjacent uplands are wooded and contain public water supply wells and a wellhouse.

Species which were observed to be dominant primarily in the wetlands include White Oak, Swamp Dogwood, White Pine, Highbush Blueberry, Buttonbush, Devil's Beggartick, Joe-Pye-Weed, Winterberry, Cinnamon Fern, Royal Fern, Sensitive Fern, Tussock Sedge and hydrophytic grasses. Several species are common in both the wetlands and uplands including Red Maple, European Buckthorn, New York Fern and Poison Ivy. Species abundant primarily in the uplands include Black Oak, Sarsaparilla, Hayscented Fern, Lowbush Blueberry, Canada Mayflower, Princess Pine and upland sedges. The attached Bordering Vegetated Wetland Determination Forms provide greater detail on the vegetation, soil conditions and hydrological indicators.

The MassGIS MassMapper does not show any Estimated/Priority Habitat Areas or Certified Vernal Pools on the site.

The MassGIS MassMapper shows nearly the entire site within a 100-year Flood Zone. Your surveyor will need to determine its extent either based on topography or graphically as appropriate,

The delineation was based on features visually apparent and the regulations in place at the time. As you are aware the interpretation of the boundaries of wetlands can vary depending on many factors including the time of year, growth phase of vegetation, groundwater levels, soil conditions, weather, and other factors. As a result, no delineation can be considered definitive until it has been reviewed and verified by all of the relevant approving authorities.





Wetland at Plot A31-W




Upland at Plot A31-U




Soil at Plot A31-W




