Through Access between Phase I and Phase II across existing culvert
2. Phase I – No. of Units = 117 Units (39 Buildings)
Phase II – No. of Units = 39 Units (13 Buildings)
3. Phase I – Primary Roadway length = 3,610 ft.
Lakeview Avenue Emergency Access Length = 800 ft.
Phase II – Roadway to Lake Street = 1,875 ft.

5. RFA Impact (100' Inner Riparian) = 10,550 sf.
6. Wetland Impact – Access Across Existing Culvert = 480 sf.
