The Chairman opened the hearing for 161, 163, 167 Mechanic Street.

The applicant representative Keith Lincoln provided an update from the previous meeting. There was a video taken of the 12-inch pipe crossing at Route 140 which is the connection of the catch basins which are proposed to install on the south side of Mechanic Street. To date, the Commissioners have not seen the video. Mr. Dion communicated that after viewing the video, the pipe is in structurally good condition and the pipe has not settled due to depression of earth work. On the opposite side of the street, there is some water in the pipe. The water is at the end of the run at the northerly side of the road. The spillway area has evidence of leaves, growth and water is not flowing as intended. This seems like a maintenance issue perhaps there was some blockage due to silt. It was noted that the manhole was buried. The video will also be provided to Consultant DiPietro. The applicant is willing to maintain the cleaning of the structures in lieu of relying on DOT to do this with the understanding that approval from DOT is provided. The Commission is amenable to this. It is recommended to show this work of raising of manhole on a plan. The O & M plan will be revised.

The Chairman opened the hearing for 550 Wrentham Road.

The applicant for the project is Denis Fraine. The applicant representative is Peter Lavoie from Landmark Site Design Engineer and Land Surveying. The Notice of Intent is for the repair of a septic system.

The applicant provided a share screen.

This is a 15,000 sq foot lot with a two-bedroom house. There is a failed cesspool which is 70 ft from the wetlands. The applicant would like to install a two-bedroom system stone and pipe design which is a nine feet wide by 47 feet long with a new two compartment septic tank. The new leach field will be 68 ft which is the closest point to the wetlands. The backyard will remain the same. The soil testing was completed with the Board of Health witnessing. The grade in the back yard will also remain the same. There will be straw wattles placed along the 50 ft. buffer. There has been no request for waivers.

The Chairman noted that the site was visited by himself and the Conservation Agent. There is a resource area, but it is off the lot but visually you can see that it is substantially lower than the lot itself. The system will be at grade. The setback is met.

The Chairman recommends that the hearing be closed, order of conditions signed and issued.

The Chairman opened the hearing for 51 Lakeview Avenue.

The Commission is in receipt of an application from applicant Andy Finley who resides at 51 Lakeview Avenue. The Engineer on the project is Margaret Bacon. There was a screen share shown. The proposed project includes the replacement of an existing two-bedroom cess pool for a residential single-family house, that will replace the existing failed system. Due to the existing site constraints and retaining walls, the proposed replacement includes a 2,000-gallon tight tank. The area of disturbance is the existing paved parking area across the street from the house and adjacent to Silver Lake. The area will be returned to a paved parking area, however it will require crossing the town right of way and will require DPW oversite. The erosion control will be installed prior to construction and will remain in place until the site is stabilized.

Upon review, it is recommended to close, issue, and sign the Order of Conditions.
