To notify the Water & Sewer Department at 24 hours in advance of my starting work on a connection to the public sewer and one hour before an inspection of the pipe installation work is needed. I will not bury any portion of the installation until it is inspected by the Department.

No sewer installations will be allowed on weekends, holidays, and all inspections will be done between the hours of 8:00 am and 4:00 pm. Any excavation which must be left open overnight due to my inability to complete the necessary pipe work for inspection, during inspection hours, is fully my responsibility.

Acceptable permits will be available three business days from the date on which it was received by the Department. No work may be undertaken until the permit has been issued.

I understand that failure to complete all blank lines in this section will result in rejection of this permit application.




