CONTINUED PUBLIC HEARING

161 & 169 MAPLE STREET:

The applicant, Will Boyle, LMP Properties LLC and owner John D. Raymond, Jr., LMP Properties, LLC propose site improvements to the existing bulk storage and mulch processing operation at 161 and 169 Maple Street in Bellingham, shown on Assessor's Map 26 Lot 01 and 26-01A.

The applicant Kim was present during the zoom call. The Board is in receipt of a sound/noise study peer review dated March 19, 2021. The applicant is seeking a continuation to address the items which included updating the plans and the concerns about the state fire code along with a

noise peer review. The applicant has provided funds for a noise peer review. The peer review noted that the current noise report provided by the applicant is lacking in addressing the local and state bylaw. It was explained that the applicant is working on addressing some of the items noted in the peer review letter. The Board at the last meeting mentioned adding a pole to give the demarcation of the 60 ft. in height so that the Fire Chief could just drive by to make sure the mulch piles are lower than the pole. A recommendation was to have the Fire Chief be at the April 8, 2021 meeting. There also needed to be added a detail for the fence. The gate for the stormwater was also going to be moved. The emergency around the area needed to be wider. The turning radius out of the site was going to be addressed by the applicant. The Board was made aware that this hearing has been open since October 2020. The Consultant for the noise study is available for the meeting on April 8, 2021. The Attorney communicated that she would like to have this completed at the next meeting.

On a motion made by Brian Salisbury, seconded by Elizabeth Berthelette, the Board voted by Roll Call to continue the hearing for 161 & 169 Maple Street to April 8, 2021.
