The Town Planner read the public hearing notice.

The applicant Bill Hasling was present representing the applicant. He provided a share screen of the plan of land dated April 5, 2021. Mr. Hasling explained that the site was used as a saw mill for many years. The owner Mr. Thomas Burr and Robin Decasse want a back lot by creating a three-building lot. The land area is 830,114 (19.06 acres). The upland is 469,700 and the frontage is 538.19. The total frontage for Lot 1 is 201, Lot 2 frontage is 201, and Lot 3 frontage is 136. Each of the lots meet the lot requirements. There are wetland resource areas on the site. The Board was made aware that the application does meet the requirements for a back lot

subdivision. These will all be single family homes. The property needs to meet the 90% upland requirement. There was a question about the easement. The Board will get a copy of the conveyance.

Questions from the public:

Resident, Roland Lavely was wondering if there is adequate frontage. He also wanted to know what will happen with Parcel A. Representative Halsing communicated that is he not aware of what the applicant plans for Parcel A.

The Board discussed putting a condition put on Parcel A that this is unbuildable. He also wanted the minutes to indicate that the Engineer through the applicant communicated that there is no desire to do anything with parcel A. The owner wants to retain ownership of this. It was noted that the wetlands do not match the GIS wetlands.
