7:00 PM — Public Hearing on the petition of Verizon and National Grid for plan number 30726530 to install one JO Pole on Mechanic Street. Remove one JO Pole on Maple Street. Relocate 1 & 2 JO poles on Mechanic Street and Maple Street. Beginning at a point approximately 10 feet North and West of the centerline of the intersection of Mechanic Street and Maple Street and continuously approximately 450 feet in a North and West direction. Relocating three poles, replace load break, install 50KVA XFMR, 1 pole and push brace and transfer hardware. Also, for permission to lay and maintain underground laterals, cables, and wires in the public ways for the purpose of making connections with such poles and buildings as the petitioners may desire for distributing purposes.
