Dear Attorney General:

I hereby certify that the following motion was adopted under Article 4 by voters of the Town of Bellingham at the Special Town Meeting of June 27, 1979:

ARTICLE 4. ZONING BY-LAW AMENDMENT

VOTED: That the Town amend the Zoning By-Law by amending the Zoning Map, rezoning from Residential District to the B-2 District an area of approximately 15 acres bounded on the west by the eastern sideline of Pulaski Boulevard, on the north by the southern sideline of Lot 63 on Assessor's Map #87, on the east by the brook which is currently the western boundary of the existing Suburban District, and on the south by the northern sideline of Lot 7 on Assessor's Map #91 extended to the above brook.

VOTE: Yes 72; No 32: Total 104
2/3 of 104 being 70, the motion carried.



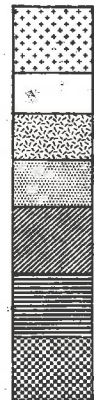


