Dear Attorney General:

I hereby certify that the following motions were adopted under Articles 2 and 5 by voters of the Town of Bellingham at the Special Town Meeting of September 5, 1979:

ARTICLE 2. ZONING BY-LAW AMENDMENT

VOTED: That the Town amend the Bellingham By-Law by amending the Zoning Map, rezoning from Suburban and Agricultural Districts to Residential District all that land on Assessors Map #91 which both lies south and west of the southwest property line of Parcel 6 and lies between Arnolds Brook and the Peters River, comprising of Lots 27 through 47 inclusive as outlined on that map, plus a portion of Lot 21, an unnamed right of way, and a portion of Pine Grove Avenue.

ARTICLE 5. CODE OF BY-LAWS AMENDMENT

VOTED: That the Town amend Section 2-33.16 of the town by-laws entitled Reimbursement for Travel by (a) deleting the words annual town meeting and substituting in place thereof the words town meeting and; (b) to authorize the reimbursement for travel expenses for the fiscal 1979-1980 year at the rate of 17¢ per mile, subject to appropriations.






